AGREEMENT TO PROVIDE COVERAGE UNDER SECTION C
FOR CONTENTS OF THE DESCRIBED MOTOR HOME OR VACATION TRAILER
(For Use In Alberta Only)

In this endorsement:

"Motor Home" means an automobile designed to include living quarters which form a permanent fixture of the automobile.

"Vacation Trailer" means a vehicle which is not self-propelled, designed to include living quarters and is of the type commonly referred to as a Fifth Wheel, Camper Unit, Tent Trailer, Vacation Trailer or Holiday Trailer.

"Contents" means the personal property belonging to the Insured and is usual to the use of the Motor Home, but does not include money, securities, gold bullion, credit or debit cards, jewelry, furs, silverware, gold ware, pewter ware, passports or any other forms relating to personal identification.

"Replacement Cost" means the actual cost to replace, or repair, damaged or lost Contents with Contents of like kind and quality providing that the damaged or lost Contents were not obsolete or unusable at the time of the loss or damage.

In consideration of the premium charged on the Policy but only with respect to the subsection(s) of Section C of the Policy for which indemnity is provided, in the event of loss or damage, the Insurer agrees that SECTION C - LOSS OF OR DAMAGE TO INSURED AUTOMOBILE has been modified to waive Exclusion 1 (e) of SECTION C of the Standard Automobile Insurance Policy and include:

The Insurer also agrees to indemnify the Insured against direct and accidental loss of or damage to contents of the described Motor Home or Vacation Trailer. This loss or damage must result from a peril set out below for which indemnity is provided.

Table with 4 columns: Insurance Coverage, Coverage Provided under Section C, Deductible for loss or damage to contents, and a note: A deductible applies for each claim, except as stated in your policy.

Provided that:

(a) Under this section of your Policy, you agree that if damaged, or lost, Contents are replaced or repaired within 180 days of the loss or damage we will pay the lesser of the Replacement Cost at the time the loss or damage occurs or \$....., for loss of or damage to the Contents of the described Motor Home or Vacation Trailer under Section C of the Policy, "Loss of or Damage to Insured Automobile". This coverage is subject to the deductible shown above;

(b) The perils for which indemnity for loss or damage to the Motor Home or Vacation Trailer is provided in this endorsement shall be the same perils as are stated in the similar subsections of Section C of the Policy to which this endorsement is attached.

If more than one Motor Home or Vacation Trailer is insured under this policy, this endorsement shall apply only to the Motor Home or Vacation Trailer against which the CAE #1 is designated in the schedule of automobiles forming part of this Policy.

Except as otherwise provided in this endorsement, all limits, terms, conditions, provisions, definitions, and exclusions of the Policy shall have full force and effect.
